ABSTRACT

Fish farming is a cardinal aspect in agricultural practices in the Tropics. Apart from being an excellent source of protein and a recreational exercise, it could as well serve as a source of income to farmers, agricultural institutes and the Government.

With the precarious nature of the business, indept knowledge is needed particularly in the area of disease management. Being a device of high versatility, computer, particularly the aspect of Artificial Intelligence (AI), can be employed for this purpose. It will offer experts' advice to successfully manage the farm - in this respect, it will help in diagnosing diseases, recommend appropriate drug and preventive measures, provide consultancy services in fish pond management and establishment.

To this end, the computer will be programmed using dBase IV, a powerful example of Database Management System (DMS), which provides a full relational database environment.

The scope of the project is restricted to only a few, but important fish diseases and problems related to fish in the tropics. This is due to the vastness and complexity of fish farm management. However, the system is designed in such a way to allow for future expansion of the scope.

CHAPTER ONE

1.0 INTRODUCTION

1.1 A REVIEW OF FISH FARMING IN THE TROPICS

Fish farming involves capturing immature specimens and then raising them under optimal condition in which they were well fed and protected from predators and competitors to attain maturity.

In the past, fishing in the wild has been the only source of fish for man. Therefore, the use of natural free - standing ponds and lakes for keeping fish is the basis of the most ancient types of fish farming.

As the human population increased and the problem of food shortage presented itself, people had to device other means of increasing food supply.

Though very vast and expanse with multitude of fish and other aquatic species, the water ecosystem has been mismanaged and overexploited by man while some fish species and other marine stock have greatly depreciated even to the point of extinction. Cushing D. H. (1977).

In order to produce more fish for consumption, a method of rearing fish domestically was devised.

According to the encyclopedia Britanica (1982), the practice of rearing fish started long before 1400 BC as Egyptian drawings attest.

Carp species in particular have been raised in ponds for several

thousand years in China and India. However, it was not until 1733 that a German farmer successfully raised fish from eggs that he had artificially obtained and fertilized. This appeared to be the beginning of scientific fish breeding and cultivation.

At that time, much attention was not given to the type of fish species being reared. Nutritional requirements of the fish, water management and diseases control were not equally given attention.

Also, there was no regulation over the pattern of breeding and growth of the species. This becomes a critical factor when a prolific breeder, such as <u>Tilapia</u>, is raised. It could lead to overpopulation and subsequently, competition for resources. As a result, the fish would not attain the growth target. Paul Bryant <u>et al</u> (1986).

Over the last fifty years the popularity of fish farming in the tropics has swiftly increased. Therefore most of the culture ponds in use today are to some degree artificial and the water supply not necessarily river or stream but could be spring, even borehole. This meteoric rise has been linked with advances in aquatic biology and the search for alternative food sources, together with increasing pressure from leisure pursuits. Bryant et al (1986).

Fish are produced not only for food but also for the extensive tropical and sport fish markets as well as tourism. Lowe - McConnell (1977).

By the end of the last century, fish culture contributes not less than 5 million tones of fish to the total world catch each year. This is about 6% of the annual global fish harvest. With the advent of modern farming techniques, there has been a considerable improvement in the yield from fish farm all over the tropics. Bryant et al. (1986).

Today, before a fish species is raised, it has to be rated in the background of its breeding and growth rates, hardiness, ability to breed in captivity, ability to tolerate wide range of changes in ecological parameters, food conversion co - efficient and its susceptibility to diseases and parasitic infections among other considerations.

Researches on the susceptibility of fish for farming are being carried out in Africa (in particular Cameroun) and South America. Lowe McConnell (1977).

Being a high fecundity animal, a fish can lay as much as 10 million eggs in a year. This will of course lead to overpopulation considering the degree of natural productivity of our waters in the tropics. Cushing (1977). The problem is tackled today by co - stocking predatory fishes, such as <u>Clarias lazera Hemichromis fasciatus</u> and <u>Lates niloticus</u>, in right proportions. They will eat - up the excess fries thereby suppressing the population.

Rearing <u>Tilapia</u>, species, a prolific breeder, a population - control technique is today adopted by feeding the fish population with

steroid supplement diet from the fry stage. In about one month, all the females become male. This will prevent the excessive production of eggs (by female). Sinha (1993).

In fish farming, crossbreeding can be easily carried out to blend desirable traits from two species thereby improving the genetic composition of the offspring and subsequently maximizing yield.

Another aspect of fish culture in tropics that has received a relatively great improvement was that of fish nutrition. Various types of supplementary feeds are in existence, which provides the required proteins, carbohydrate, fats, vitamins and minerals. Combining these proportionally has maximized yield and made the fish attain the target weight within a short time. Some of these feeds also confer on the fish the ability to withstand certain diseases and infections.

Further improvement came in the area of water management to reduce the degree of water pollution from fish wastes and other sources. This is by introducing water-recycling system. This also removes soluble wastes such as ammonia.

In area of fish diseases, a good number of drugs are available to treat the diseases and parasitic infections. Many practices abound today which farmers can adopt to avoid incidences of infection and diseases. It should be noted however that the construction, running and output of fish ponds is up till this moment, a subject of much investigation. Bryant et al (1986).

1.2 AIM AND OBJECTIVE OF THE STUDY

Today there is a growing recognition of computer science as a laboratory science and its application in solving problems and efficient accomplishment of various tasks in virtually all areas of human endeavor.

Applying computer to fish farm management will go a long way in boosting fish production for human consumption, recreation and economic purposes.

Fish is known to contain, proportionally, a greater amount of edible flesh than pigs, sheep, cattle etc. And it needs to eat a smaller quantity of food to produce this flesh. Bryant et al. (1986). Since aquacultural practices produce mainly animal protein, which is the nutritional staple in shortest supply in developing countries, considerable hope needs to be given to the practice.

Fish are known to be prone to a wide range of diseases and parasitic infections and they can only tolerate relatively small changes in their physical environment. Therefore, outbreak of a disease could lead to the destruction of the entire stock! Moreover, these diseases are not easy to diagnose particularly by layman in the field.

It can therefore be concluded that the importance of fish and fish farming can not be overemphasized.

In the light of this, it will be worthwhile if a computer package is constructed to aid fish farmers in management of their farms and guide prospective farmers to undergo a successful venture in fish farming.

The project is aimed at achieving this by primarily using *EXPERT SYSTEM* to proffer solution to the problems associated with fish farm management especially as concerned disease diagnosis, vis-à-vis symptom, causative agents, prevention and cure. In addition, the program will contain a database from which farm managers can draw necessary information in other aspects of daily running of the farm.

The database will also contain a guiding instruction for prospective farmers needed in establishing a fish farm vis-à-vis which fish to farm; the nature of soil suitable for the pond; water source; ideal feed combination to maximize yield etc.

1.3 ARTIFICIAL INTELLIGENCE

1.3.1 <u>DEFINITION</u>

Though many definitions and descriptions exist of artificial intelligence, the overall consensus is concerned with automating those human activities that have not been automated before.

Artificial intelligence - A.I - can therefore be defined in the way

of Tanimoto (1987), as "a field of study that encompasses computational techniques for performing tasks that apparently require intelligence when performed by human".

1.3.2 HISTORY

In early 1940s the first electronic general-purpose computer, ENIAC, was invented by Mauchly and his associates. Up till that time computer was regarded for its speed at processing, vast memory capacity, accuracy and compactness.

In the mid-1940s, H. H. Goldstine et al conceived the idea of a computer that will operate on binary system with stored instructions internally in the machine EDSAC was then constructed, precisely in 1949. It was operating without any cognitive ability.

In 1950, the domain of study in computer science was broadened to include the possibility of transferring human "intelligence" onto a machine. This led to the birth of Artificial intelligent. Doukidis G. I. et al (1988).

In 1959, the first industrial robot was introduced by animation. It followed a sequence of motion steps determined by instructions (Program) to automatically carry out a variety of tasks at a relatively low cost.

However there are records of devices made by man, which

behaved "intelligently" as far back as fourth century. A golden Buddhist was said to sit on a carriage and tended by animated models of Taoist bowing and saluting and throwing incense into censer.

In 790AD, a wooden otter was devised in China, which was said to catch fish.

In 1879 Villiers de I'Isle Adam depicted a remarkable woman animated by electricity.

In the moment Artificial intelligence is applicable in several areas of human endeavour as industrial robots, legal advisor, medical experts, laboratory analyser e.t.c.

1.3.3 AREA OF ARTIFICIAL INTELLIGENCE

Doukidis et al (1988) subdivided artificial intelligence into three major areas. These are:

- i. Language Communication: This is concerned with computer understanding natural language and translating from one to another.
- ii. Environmental Manipulation: It is primarily concerned with robots. Attention is focused on vision system, which involves how robots can examine objects and places thereby manipulating the environment in which they find themselves.
- iii. Knowledge Manipulation: This is known as intelligentknowledge Base IKB or knowledge Base system KBS. It is

concerned with manipulating information in a particular field, logically, thereby turning out a recommendation with remarkable proficiency. Expert system belongs to this area.

1:4 EXPERT SYSTEM: AN ASPECT OF ARTIFICIAL INTELLIGENCE.

Expert system is a new opportunity in computing and it is classified under the area of artificial intelligence called Intelligent Artifact or knowledge Base System (KBS).

It solves problem using knowledge culled from human experts and it restricts itself to a single domain of expertise. Thus it is domain specific oriented.

As defined by Sell (1985) and Jackson (1986), Expert system is a knowledge based system that emulates experts in a particular domain of expertise. The process of constructing the system has been termed "knowledge engineering".

The first expert system, *Dendral*, was built in the 1960s. In a typical expert system, there must exist a mechanism for navigating the knowledge base - the inference engine.

1.4.1 FEATURES.

For an expert system to perform and solve a problem to a logical end, it must possess these features:

- i. Significant Performance Capabilities: The system must perform at least, as well as the expert in the field. It should not be expected however to perform better than an expert. In a case it does, this is regarded as a plus to its capability.
- ii. Maintainability: Human expertise is changing all the time as new facts, techniques and findings emerge. As such, an expert system must provide the user with a similar level of flexibility as humans in modifying its knowledge base.
- iii. Simplicity: The system must converse with user in a manner simple enough to have a meaningful interaction and with the least difficulty in extracting solution to a problem. It must, in other word, be user friendly.
- iv. Reasonable response time: The program should not take an unreasonably long time between questions or producing answers to the questions. Otherwise, the old system would be preferred.

1.4.2 <u>MODEL</u>

A typical expert system comprises a number of modules of program, which work interactively to solve problem at a particular time. Basically the expert system model consists of four parts as described by Doukidis et al (1988). These are:


- i. the knowledge base
- ii. the inference engine

- iii. the user interface
- iv. the working memory.

These days an expert system can be complex in its composition to contain some more advanced features.

A diagrammatic way of representing the relationship between the different parts is shown below.

Fig 1. The simple expert system model (After Doukidis et al).



- i. The knowledge base: This is made up of a set of files that stores the Knowledge obtained from experts as production rules -, which the system relies on to provide the user with useful information about the domain. It is also known as knowledge bank.
- ii. The inference engine: A knowledge base is of no use without an inference engine. The 'engine' manipulates the knowledge base to provide new information.

Typically, in a production rule system, the inference engine uses some form of logical deduction to provide the answers.

- iii. The user interface: For the expert system to be of any use, it must communicate with the user this is done through the user interface either directly via the screen and keyboard or indirectly via external links to machines and monitoring devices e.t.c.
- iv. The working memory: This contains details of the state of the systems knowledge at a particular time. Thus, at the start of the working, the memory is empty. As the system is used, any new fact derived by the inference engine are stored in the working memory, which increases in content during the query process.

1.4.3 EXAMPLE

The following are examples of expert system used in various domain of expertise.

CHAPTER TWO

2.0 THE PROJECT IN BROAD PERSPECTIVE

2.1 COST IMPLICATION OF NEW SYSTEM

For the new system (computerized) to perform, it is important to acquire the list of some computer components, and their respective cost. Shown below is the list of such components.

2.2 FISH DISEASES AND MANAGEMENT

Fish, like other animals are affected by myriad of diseases, which manifest with various symptoms. The subject of fish disease is a complex one considering the diversification in type, symptom and geographical distribution.

The farmer must be familiar with the symptoms of at least a few of these diseases, for it is certain that he will encounter some of them at one time or another. Some are easily identified, others, much difficult, still more, some with virtually no symptom but only a sudden decimation of the fish population! However, diagnosis becomes easier with experience.

Basically there are four types of organism responsible for diseases in fish. These are Fungi, Bacteria, Viruses and Parasites.

Incidences of virus should be reported to the local Veterinary surgeon, as some drastic measures need to be taken to curb the spread of the disease and any possible re-occurrence. Most often the entire stock is destroyed. Cases of bacteria infection too need to be reported.

Any fish that died "naturally" should be examined immediately, both internally and externally to ascertain the cause and prevent any reoccurrence.

If the water is sourced from river or stream care should be taken to screen out any 'wild' fish which mostly accommodate a host of diseases and parasites. The water should be well treated if needs be.

It was established that a deficiency of some of the food sources, particularly Vitamins, in fish diet leads to the appearance of characteristic deficiency symptoms. Some of these symptoms are exactly like those of parasitic or disease infections. Thus, the farmer may find it difficult to contradistinguish between the symptoms from an infection and food deficiency symptoms.

To tackle such problem, the program is made to diagnose any disease after sufficiently querying the nature and nutritional content of the food fed to the affected fish. At the end, both treatment and deficient food sources are recommended.

2.2.1 MAINTANING A DISEASE-FREE POND

A good way of ensuring a disease free pond is by liming (application of lime). Lime is best applied to a pond before it is put under water for the growing season. It serves as a preliminary treatment before stocking.

Every new batch of fish brought into the farm should go through a quarantine period when they are kept separate from the other fish and observed for any possible disease before being released into the pond. Good hygiene is also essential, for dirty equipment and habits transmit diseases to the fish. Farmers are advised to clean and disinfect the farm tools-buckets, tanks, nets, and boots, gloves e.t.c- with dilute bleach or commercial disinfectant. 10% solution of sodium hydroxide (caustic soda) is very good and recommended.

The farmed fish themselves should always be obtained from a reputable source.

Farmer should be conversant with all these information. And they should be incorporated into the database module of the program for consultation by the farmer.

2.3 THE EXISTING SYSTEM

A study of the existing system was carried out with visits and interview conducted with the Department of Fisheries, Ministry of Federal Capital Territory, Area 11 Abuja.

It was a fenced farm occupying a landmass of about two hectares with ten earthen ponds and a relatively large reservoir.

At the entrance of the farm is the hatchery. It is the building that normally accommodates tanks and other farm equipment. There, artificial insemination, breeding and rearing of fingerlings are carried out. Various tests and treatment of diseased fish are also conducted in the hatchery.

From the studies, it was gathered that most farmers have very limited knowledge of the diseases of fish and their management. The only methods of diagnosing fish disease which they mainly rely on, is by looking out for any wound or laceration on the fish or a dead fish in the pond.

These methods are just few and inefficient looking at the various ways of diagnosis. Besides it is very unsafe to wait till even a single fish dies to get the farmer notified of any imminent danger in the pond.

Another deficiency in the existing system is the total absence of autopsy when a fish dies. Should it be carried out, it would not be thorough, as the farmers do not have a comprehensive knowledge of what to look out for on dissection.

Of the available drugs for treating diseases and infections of fish, only a few - Malachite green, formalin and potassium permanganate- are well known to the farmers. This of course, is an indication of their level of understanding or the attention given to fish diseases as the case may be.

A typical fish farm establishment, profit oriented, sources its income from the sales of fingerlings (young fish), juveniles, brooders, ornamental fishes, aquarium design and sales as well as from consultancy services.

From the studies, it is indicated that the aspect of diagnosing and treatment of fish diseases is still very defective in fish farm management in the tropics.

A fractional part of the activities in the farm are automated. This amounts to time wastage and unproductivity.

This, among other reasons, necessitates the introduction of computer into the system.

CHAPTER THREE

3.0 SYSTEM ANALYSIS AND DESIGN

3.1 FEASIBILITY STUDIES

A project of this nature demands much labour, time and financial requirements. A preliminary investigation of such a project, which will subject it to a test of importance, viability and practicability, is therefore necessary prior to the implementation stage. This is called feasibility study.

The study was conducted under the following sub-headings.

I. UNDERSTANDING THE PROJECT

The new system is aimed at using computer to do some of the things the farmer has been doing mechanically before. These could be summarized thus:

- (a) Providing necessary diagnostic facts on various diseases of fish more reliably and uniformly on any occasion, and recommend appropriate treatment or control.
- (b) Making available information needed by farmers and prospective farmers in daily management of fish farm.
- (c) Storing these information in an automated system more safely and in a way that will be more accessible to farmers when needed.

(d) Outputting any needed information in form of hardcopy or softcopy.

II. SIZE OF THE PROJECT

The system will require one computer system - a Central Processing Unit (CPU), monitor, Printer, Keyboard with other necessary electrical accessories. The system will be suitably set up in a demarcated part of the farm hatchery.

It will be manned by two of the farm attendants who must have received adequate training in microcomputer operation and management.

III. TESTING PROJECT FEASIBILITY

In system analysis and design the feasibility of a project is criticized on three backgrounds.

- a. Economical feasibility
- b. Technical feasibility
- c. Operational feasibility
- (a) *Economical Feasibility*: From the analysis of the cost implication of the new system as presented in chapter two, page 14, the system will cost a total sum of One hundred and nineteen thousand seven hundred Naira only (N119, 700.00k).

General maintenance and servicing system will take place from

time to time. Also, provision will be made for security and all other measures that will enhance smooth running of the system.

The study of the existing system indicates the various sources of income to the organisation and there is always a regular demand for the products and services. Being an economically productive venture, the farm, or any modern fish farm for that matter, will comfortably embark on such project (computerisation) without any adverse economic implication.

The system, when installed, could also be used for some other purposes in the farm such as word processing, inventory, and record keeping - on the fish stock, sales, fertilization and hatching dates. With this, the benefit of embarking on the project will certainly outweigh the cost. Therefore, it can be rightly concluded that it is economically feasible.

(b) *Operation feasibility*: - This is concerned with the workability of the proposed project considering the ways and methods of implementation as dictated by certain factors.

The system is programmed in such a user friendly way that any computer literate person will be able to communicate meaningfully with the system.

The database is composed with virtually no technical term of aquacultural studies. This will make it usable even by new comers in

the field. The installation of air-conditioner as the cooling mechanism for the system will ensure an ideal environment for the system to function.

(c) Technical feasibility: - This tests whether the existing personnel, equipment, and the level of technological development, as the case may be, will support the proposed project.

The various hardware and software components required are listed in chapter two, page 14. They are all readily available and will allow the system to perform within the limit of modern computer technology.

In terms of speed of processing data to ensure a good response time, the recommended Pentium series will fittingly accommodate both the operating system and the written program.

Sometimes certain component parts need to be replaced. Being an International Business Machine (IBM) compatible system - locally assembled, - the system can accept spare parts from other computer companies other than IBM. These parts are readily available and at a cheaper rate. On the contrary, a branded system will only accept spare component from IBM or the particular company that manufactured the system.

3.2 <u>INVESTIGATION AND FACT FINDING</u>

These are the techniques and methods of gathering information.

The project adopted these three methods:

- (i) Record Searching: A good number of reputable texts and journals were consulted for information on pisciculture, aquaculture, computer technology as well as business management. Past works on related topic were also consulted for guides.
- (ii) Interview: Interview was conducted with those knowledgeable in fish farm management and project management. Hardware and software vendors were also interviewed.
- (iii) **Observation**: This was made in the fish farm where some hours were spent observing / studying the activities of the farm attendants. An expert system package, though on a different topic, was studied for some more technical details in writing expert system program.

3.3 REQUIREMENT SPECIFICATION

This is a stage of system design and analysis that involves stating clearly what the new system requires to efficiently perform.

Normally, it is the product of studies carried out on the existing system (system analysis) during which the system is thoroughly

scrutinized pointing out the weaknesses and otherwise.

The specification will therefore state the needs required to computerize the system for better performance. Table 1 shows the details of this.

3.4 SYSTEM REQUIREMENT

documentation of what the system will look like, produced in hard copy and presented to the management for study and possible approval before the commencement of project execution, is normally made. This is termed system specification or system requirement.

After arriving at a required specification, a detailed

In summary, it serves the following purposes:

- (i) Formal communication with the management about the proposed system.
- (ii) Provides complete record of the system, which is needed, for the purpose of evaluation, modification and training of personnel.

Below is the system specification for the project.

- 2. <u>SCOPE</u>: The scope of the project will be limited to the fish in the tropics. And the system will offer limited information on food preparation formular and administration to avoid inconsistencies.

It is believed that food administration methods and formular vary with the prevailing climatic condition, age, state, health of the fish, natural productivity of the water e.t.c.

- 3. *PERSONNEL*: The services of the following will be required.
 - (a) System Analyst: He will study the existing system and come up with a design of new one. He will also be consulted for maintenance and advice after the implementation of the new system.

- (b) **Programmer:** He will, from the report of the analyst, design appropriate program(s) to solve the problem and accomplish the aim and objective of the organisation.
- (c) *Computer Operators*:- Two of the farm attendants will be trained in micro computer operation and management. They will be the only staff members operating the system.
- 4. <u>SECURITY</u>: The management will ensure the following:
 - (a) The system should generally be handled with care.
 - (b) The system would not be made accessible to outsiders or non-trained staff members without permission by the management.
 - (c) Back up copies of the software would be procured and safely kept.
 - (d) Anti virus kit would be installed in the system.
- 5. <u>REQUIREMENT AND COST</u>: The following will be required for effective implementation of the project:

- 6. <u>LOCATION</u>: The system would be installed within a reasonably safe distance from water tank in the hatchery. The place would be demarcated from other parts of the hatchery where the optimal temperature of the tank will not be altered by the A/C.
- 7. <u>USING THE SYSTEM</u>: The following should be noted:
 - (a) The operators should be familiar with the system by time to time consultation even if no disease is noticed.
 - (b) On discovering any disease symptom or disorder, the observation should be carefully noticed and any dead fish dissected and examined before the system is consulted.
- 8. <u>COST BENEFIT ANALYSIS</u>: Embarking on the project will be of

great benefit to the establishment for the following reasons:

- (a) Wrong diagnosis of disease and prescription may lead to poor yield or outright extermination of the entire stock. The system will guide against this.
- (b) The system will provide guiding information towards a successful fish rearing.
- (c) The organisation will be able to retain the information and many others mentioned earlier under economical feasibility in a reliable and permanent medium.
- (d) The exit of a farm attendant will not affect the organisation as such since the knowledge is equally stored in the system and a new user can take over the management of the farm with little or no difficulty.

3.5 CHANGEOVER

When the new system has been tested and it is proved satisfactory, a change or conversation from the old to the new system would take place. This is termed changeover.

Changeover may be achieved in a number of ways. Important among these are:

- i. direct method
- ii. parallel method / running
- iii. staged method.
- i. **DIRECT CHANGEOVER**: This means processing data entirely with the system after replacing the old one in a single move. The method should be adopted only when everyone involved has appreciable confidence in the new system. It is a risky method in a way.

For security reasons, the old system is kept in abeyance in case any problem arises.

ii. **PARALLEL RUNING**: This method involves processing data by both the old and new systems (methods) concurrently to compare the results and know if the new one will serve.

It is an expensive method as it involves maintaining two systems at a time. It is equally time consuming running two systems at a time.

iii. **STAGED CHANGEOVER**: This involves a series of "limited-size" direct changeover, the new system being introduced piece - by - piece.

Any tested and reliable section is brought in for implementation.

Considering the nature of this project (an information system), the parallel running method is recommended. With the method adopted, the farmer's knowledge will be complimented and up-dated by the system as often as he uses it.

CHAPTER FOUR

4.0 SOFTWARE DEVELOPMENT

4.1 **PROGRAMMING TECHNIQUE**

Software is described as a set of sequence instructions which informs a computer of steps to take to achieve a defined task. In other word, software directs the affairs of a computer.

In software development, adopting a computer language is a choice that has to be made after taking into consideration, the nature of the problem to solve and area of human endeavour concerned.

This program is developed using dBase IV, a type of high level language, which is applicable to virtually all fields of specialization. dBase IV belongs to the group of programming package / language generally termed Database Management System (DBMS). Within the group is a number of dBase versions. dBase IV is an advanced version of dBase and it provides a full relational database environment to users.

Dbase4 IV provides a screen design facility for users to customise and design the screen both for input and output. It is said to be one of

the most popular and powerful DBMS available for personal computers.

The programming language encourages running the computer in an interactive mode. As soon as the user submits a program to the computer, it executes the program and produces the result, while meaningful dialogue continues in the course of executing the program.

dBase IV is a compiler i.e. a high level language that compiles (check and certify correct) all the programming statements before producing output. It supports certain features, which makes it an easy tool to manipulate complex situation with a satisfactory output. For instance, the use of blocked operations, such as DO CASE... CASE.... ENDCASE, in accessing cases. With the programming structure, a computer will efficiently access a complex case of several conditions / possible outputs and logically arrives at a conclusion - see appendix II.

dBase IV also supports instant syntax checking as instructions are entered and it also gives instant help on errors.

The choice of this programming language is made for the project because of its versatility in solving problems. In addition to the myriad of programming commands entrenched in *dBase*, it equally supports all


the commands in the lower versions of *dBase* and a good number from *QBASIC*, another powerful programming language.

4.2 **PROGRAM STRUCTURE**

A good program should be maintainable and understandable. In ensuring this in this program, the concept of modularity has to be employed. This involves writing the program in modules. Each module is a complete and independent program that can run on its own.

Communication between modules is made possible by using certain *dBase* commands. In this program, of forty-one (41) modules, DO / RETURN Statement is used. The commands go together as a pair. While DO statement transfers control (of execution) from the main program to the sub - program, RETURN statement directs the execution of program back to the main program at the point immediately after the DO statement.

With this method of programming, the program will appear less complex, more orderly and any section of the program can be debugged or updated without having to pass through the whole program. The chart below shows the structural arrangement of the modules as a flowchart.



4.3 **SOFTWARE DOCUMENTATION**

Documentation is the description of a program in a way to inform the user and other system programmers, about what the program does, how it works and other details that will enhance maintainability.

It aids users in understanding the program better. Documentation may be internal, as in this case, where comments are made within the program using an asterisk (*) to proceed the statement. Such statement is regarded as non-executable statement. In external documentation, comments are made in form of written description and structured diagram. This could be termed "Manual" which always accompany a package on purchase. It becomes more indispensable when a program is very complex and voluminous.

4.4 <u>IMPLEMENTATION</u>

On developing and testing a program, the next step is implementation of the program. This involves applying the program to solving the problem it is meant to solve thereby making it fully operational.

This program is tested and can be used for management in backyard fish farm, large farm for commercial purposes, agricultural

institutions, school farms and in colleges of agriculture.

For effective implementation of the program, it is designed in such a user - friendly way that it will pose little or no problem to the users.

4.5 **INSTALLATION**

To run the program, the computer must already have dBase IV compiler. The following are the steps to run the program:

- (a) If the program is already in dBase directory on hard disk,
 - i. boot the system
 - ii. at C:\> type cd dBase4

 - iv. at the control panel press Esc key and press Y key in response to the prompted question.
 - v. At the dot prompt, type Do mainmenu.prg
- (b) If however the program is contained in floppy disk,
 - i. boot the system
 - ii. insert the diskette into drive A:

- iii. at C:\> type Copy A:*.prg \dBase4
- iv. then follow steps ii v above

On running the program, the first output to appear on the screen is the introductory screen shown below.

Following the instructions on the screen, the computer will continue to execute the program until the mainmenu screen is displayed where any of the three main options can be chosen for execution.

The programs, as well as the output are shown at the end of the project - Appendices II and III respectively.

CHAPTER FIVE

5.0 **SUMMARY AND CONCLUSION**

5.1 LIMITATION OF EXPERT SYSTEM

To make good use of expert systems we need to know their pitfalls and limitations. The following should be noted while using an expert system.

5.1.1 Speed of inference:

This is the most critical in a situation where optimal solutions are needed within a fixed period of time.

Medical and military decision for instance may, most of the time, be sensitive to the speed of the information processing because there may be need for the system to probe deep into the subject with an intricate network of questioning before a meaningful and precise result can be obtained.

5.1.2 Extent of Knowledge:

An expert system is limited by the extent of the knowledge built in. If the system is being applied slightly outside its area of strength, it tends to be defective in its performance or else error messages are displayed. The system at this stage is said to have a "knowledge cliff".

5.1.3 Quality of Knowledge:

An expert system is developed with knowledge acquired from experts in a given field. From observation, it is believed that when one is dealing with expert system, it is easy to get carried away with the thought of a computer that can solve practically all problems with reference to that domain of expertise.

It should therefore be noted that expert system should not be expected to perform better than the expert in that field. If however it does, this should be rather seen as an added advantage.

5.2 EVALUATION OF SYSTEM DESIGN

A developed system is evaluated using these two operational goals. This particular system is likewise evaluated.

- (1) Reliability: A system is said to be reliable if it does not produce dangerously or costly failures when used normally. Such system should be designed to avoid error, detect and correct error from the users by, for instance, displaying error messages.
- (2) Maintainability: The system should be designed to allow for maintenance. This is achieved in modern day programming techniques

by adopting the modular structure of programming and proper

documentation.

The program in particular should be written in modules and with a logic flow such that an error in a module will only affect that module so that correcting the error or maintaining the module will not affect the whole program.

There should also be comments on what a program or segment of a program does to allow for easy location of error and subsequent debugging.

5.3 **RECOMMENDATION**

The system as a whole should be run with a maintenance culture. Since knowledge is not static, and new facts come up from researches from time to time, expert system should always be accessed regularly (system feed back) and the knowledge base upgraded if need be.

With the adoption of expert system in an organisation, it is believed that "an expert" or his knowledge has been acquired. It is however advised that the new system or a new computer technology should not be seen as a replacement for the existing personnel or human experts. Rather it should be seen as an effort to complement the old system with an improved output.

5.4 **CONCLUSION**

The most important purpose of artificial intelligence is to increase man's understanding of reasoning, learning and perceptual process.

This understanding is needed to ergonomically build useful new tools in order to achieve a more mature view of human intelligence than currently exists.

The package is aimed at achieving this in the area of fish production. It is therefore recommended for use by individual farmers, schools, agricultural institutions and even individuals who might wish to have backyard fish farms as pastime.

It is noteworthy that the software has been designed with that simplicity and user-friendliness to make it usable by farmers even without any previous encounter with such package. Error messages are displayed without any ambiguity when necessary.





When observing fish...

- * both the inner and outer parts should be considered.
- * internally, the kidney, liver, gall-bladder, the intestine and swim bladder should be thoroughly observed for any abnormal appearance.

- * excessive collection of fluid in the belly should be looked out for.
- * always prepare a slide of scraped mucous from both the gill and skin for observation.

Features of a rearable fish

Rearable fish are those that can:

- i. tolerate pond or artificial conditions
- ii. grow quickly on both natural and artificial feed
- iii. reproduce or breed in captive
- iv. fairly resist diseases and parasitic infection
- v. be hardy generally

FISH POND AND MANAGEMENT

- (1) Pond design should allow for easy drainage. Thus, inlet point must be located above the outlet point.
- (2) Water depth of over 2 meters is NOT good as it would keep some parts of the pond in total darkness, and also reduce the amount of dissolved oxygen.
- (3) Moving or drainable water is recommended to run a fish pond.
- (4) The pond floor should be slightly slopy towards the outlet point to enhance easy drainage.
- (5) If the water is sourced from river or stream, 'wild fish' should be screened out because fishes in the wild are known to always harbour parasites and diseases germs.
